## **PREAMBLE**

CONSIDERING that the Parties wish to associate in order to promote peace and pursue common humanitarian objectives,

CONSIDERING that the actions of each Party are conducted by the universal values of the United Nations under a spirit of solidarity,

IN THIS REASON AND THEREFORE the Parties agree as follows:

## **ARTICLE 1**

1. The purpose of this protocol is to define the conditions delimiting the relationship between the Parties. The affiliation will permit to coordinate the Parties' actions on an international level.
2. The Association affiliates itself with the AISP/SPIA as one of its regional departments, geographically delimited in article 4 (1).
3. The AISP/SPIA recognizes the Association as its delegation in the territory defined in article 4 (1).

## **ARTICLE 2**

The actions undertaken by both Parties will be in total harmony with the goals of the SPIA, defined in article 2 of the General Statutes of 1988, and the values of the United Nations, defined in the preamble of the *Charter of the United Nations* (San Francisco, 1945).

## **ARTICLE 3**

1. The regional department attributed to the Association is Austria
2. The AISP/SPIA acknowledges only one association as its regional delegation in the country determined in the precedent paragraph.

## **ARTICLE 4**

The AISP/SPIA pledges to allow total independence on a national level to the Association.

#### **ARTICLE 5**

The Association agrees to encourage close relations with the AISP/SPIA. The Association agrees to set forth the AISP/SPIA, its aims and its objectives.

#### **ARTICLE 6**

The AISP/SPIA undertakes to refer all its eligible members residing in the geographical area defined in article 4(1) to the Association who will then take charge of their admission as members of the AISP/SPIA, under the conditions set in article 8 and those set in the AISP/ SPIA Statutes.

#### **ARTICLE 7**

1. The AISP/SPIA will only consider membership from military personnel who have served the United Nations within the structure of an army.
2. Civilian personnel who have served the United Nations or represented the United Nations' cause could become affiliated-members.
3. The personnel not mentioned above who have rendered enormous services to the Association and the cause it defends could become honorary members.

#### **ARTICLE 8**

The Association and the SPIA HQ mutually undertake to promote by every adequate means the Association mutual interests and if necessary to participate towards its promotion directly or indirectly.

#### **ARTICLE 9**

The provision of the present agreement is laid down for a probationary period of one year. The agreement will automatically be renewed to the extent where neither party wishes to annul it.

#### **ARTICLE 10**

The present protocol could be followed by an agreement binding the two associations for an unliminated period, thus this agreement will become null and void.
